

All the provision contained in the interim policy regulations shall be applicable from the academic year 2003-2004 in respect of all the AICTE approved institutions.

Further, in the event of infringement / contravention or non-compliance of the norms and standards prescribed by the AICTE during the last approved academic year, the Council shall take further action to withdraw approval to this case for admission during subsequent academic year and the liability arising out of such withdrawal of approval will be solely that of Management / Trust / Society and/or Institutions.

The Council reserves the right to visit the institution any time it may deem fit to verify the compliance of Norms and Standards of AICTE.


You are requested to kindly monitor the progress made by this institution for fulfillment of the Norms and Standards of the Council and keep the concerned Regional Committee and AICTE informed.
